Since qualifying as a Nurse in 2002, Martin has gained a broad experience in the field of healthcare. He has worked in a Psychiatric Intensive Care Unit (PICU), a Community Mental Health Team (CMHT), and a Child and Adolescent Mental Health Service (CAMHS).

Martin has been working as a Brain Injury Case Manager since 2006. In this period, he has worked with a range of adults with complex trauma and disabilities, both neurological and other conditions. Martin has been a member of British Association of Brain Injury Case Managers since 2006 and achieved Advanced Level status in 2011. Martin has held positions of case manager, senior case manager, and clinical team lead.

Martin has worked predominantly with brain injured clients but has also supported others with post-traumatic stress disorder (PTSD), spinal cord injury (SCI), amputation and polytrauma.
